

OREGON DISTRICT 1 DAILY NET PREAMBLE

Good evening. Oregon's District 1 Amateur Radio Emergency Service Net is now in session.

This is your net control station (your call, my name is (your name)) located in (City, State). This net meets daily from 7:30 to 8:00 PM local time for the purpose of preparation and coordination of District 1 ARES communications in the event of an actual emergency. During an actual emergency you would be directed to check in with your local county ARES net.

Our primary repeaters are the 147.32, 442.325, 444.400 and 147.04 megahertz linked repeaters all having a 100hZ tone, and the 146.720 megahertz repeater on Wickiup Mountain with a 114.8 hz tone. We also have an alternate repeater on 146.840 megahertz.

All traffic will be accepted and should be in correct NTS form. Emergency's will be handled at any time. Stations are asked to check-in with their callsign indicating if they have traffic, contacts or other business for the net. Traffic should be listed when acknowledged by Net Control.

Stations are reminded that compliance with the FCC rules part 97 (Nine Seven or Ninety Seven) for the amateur radio service requires a station to transmit its assigned call sign on its transmitting frequency at the end of each communication, and at least every 10 minutes during a communication. (*Includes Net Control Stations*)

Stations representing emergency groups or agencies should state their affiliation. You are encouraged to register with your county ARES unit, but any station may check into this net. Stations are reminded the Oregon ARES District 1 has a website at oregonaresd1.us.

The ARES District One Net is now open for any stations with traffic, contacts or other business for the net.

The net will now take check-ins from stations that need to secure early.

(Just release stations, Don't waste time with seeing if anyone wants to contact them).

The District 1 Net is now open for check-ins from Elected or Appointed Officials & Active Liaisons.

The net will now take check-ins from District 1 net controls and alternate net control stations. (*Active=1 Net Every 3 Months*)

The District 1 Net is now open for stations from District 1 in (Clackamas, Clatsop, Columbia, Multnomah, Tillamook, Washington,) county (*you can use any county grouping you like*).

The Net is now open for stations outside of District 1 in the state of Oregon.

The net will now take check-ins from the state of Washington.

The District 1 net will now take check-ins from any location or any stations with traffic, contacts or other net business. (*CONTINUE TILL CLOSING*)

Closing: The ARES District 1 Net is now closed at (time) PM. This net operates through the courtesy of the Amateur Radio Relay Group, Incorporated. We thank all stations who participated and those who stood by to give us a clear operating frequency. This is (your call) returning the frequency to normal Amateur use.

Alternate Closing (for 146.84): The ARES District 1 Net is now closed at (time) PM. This net operates through the courtesy of the Portland Amateur Radio Club. We thank all stations who participated and those who stood by to give us a clear operating frequency. This is (your call) returning the frequency to normal Amateur use.
